Minutes of the 2021 Electronic Annual Meeting of CEEweb for Biodiversity

Prepared at the Electronic Annual Meeting of CEEweb for Biodiversity (Hungarian name: CEEweb a Biológiai Sokféleségért, headquarters: Budapest, Széher út 40, 1021, Hungary) convened by the regulations according to the Articles of Association online via Zoom; held on 16th June 2021.

The General Secretary of CEEweb sent an informative e-mail on 1st June 2021 to the full members with the proposed agenda points and date of the electronic Annual Meeting, attached the Financial Report of 2020, Narrative Report of 2020 and the narrative report of 2020 of an independent auditor. The invitation contained the date of the electronic Annual Meeting, as well as its reconvening date, if the 50% + 1 members were not represented. Later the hyperlink of the Zoom meeting was also sent to the members in a separate e-mail.

The General Secretary determined on 16th December 2021, that 4 full members were attending the electronic Annual Meeting convened at 10.00 CET. Because this number did not meet the criteria of a quorum, the General Secretary reconvened the electronic Annual Meeting at 11.00 CET on 16th June 2021, which was quorate irrespective of the number of members participating. The General Secretary determined that 6 full members were attending the electronic Annual Meeting reconvened at 11.00 CET and that the meeting is quorate.

Between 10.00 and 11.00 CEEweb employees held an 'extended office meeting' presenting the most important projects to members.

The General Secretary confirmed that 6 full members are participating the Annual Meeting namely IMRO Foundation, DEM, Association of the Hungarian Alboreta and Botanic Gardens (MABOSZ), Friends of the Earth Hungary (MTVSZ), Ecological Tourism Europe (ETE), Albanian association of Youth and Students of Geo-science and Environment (AAYSGE). It is also found that the organisation called Eko Zivot whose membership was to be approved during the Annual Meeting was also present but had no right to vote as it was not an official member at the time of the meeting yet.

The electronic Annual Meeting reconvened on 16th June 2021 at 11.00 CET ended with the following results regarding to the resolution proposals:

2/ General Secretary: by proposing the expulsion of this member we only followed the rules of the Articles of Association. Additionally, non-paid membership invoices appear in CEEweb's books as loss. We must take care of the financial balance of the organisation as well. We will contact the first group of organisations again and will present the results (and resolution proposal) during the next Annual Meeting.
